ITEMS NEEDED FOR HANDGUN SAFETY COURSE

1. 150 Rounds of ammunition, minimum
2. Ear protection
3. Eye protection
4. Belt style holster is recommended
5. Appropriate attire for weather conditions (Cold, Rain, etc)
6. Drinking Water
7. Handgun – Leave handgun unloaded and in your car until you are told to retrieve it by the range master.
8. There will be a lunch break, during which the facility will be closed.

NOTICE:

All accepted students are hereby directed that until approved to carry a loaded weapon by the State of Tennessee, all weapons should be transported the day of training unloaded. The weapon should be unloaded and separate from the ammo, and in a locked container. The trunk of your car is acceptable. All students should get some type of firearms training prior to attending this class. The range is located on 1097 York Road. You will turn off Lebanon Road onto York Road next to the bridge across from the Cedar Creek Sports Center on Lebanon Road. Class will start at 7:00am.
